
Dear Sir/Madam,

The proposed development will be a fast-food, take-away restaurant situated on West Street (number 68 – 72, unit 1A). With the consent of the landlord we would like to partition the premises so that we can use the front part as a fast-food take-away restaurant. The other part of the partition will remain with the landlord. The applicant currently owns and operates a mobile catering unit located next to the proposed development.
