

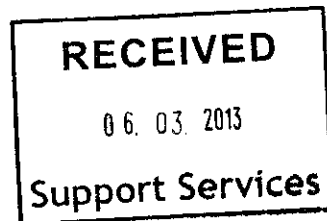

I enclose an application for the discharge of the condition no: 5 on the planning approval, concerning the acoustic treatment of the outbuilding.

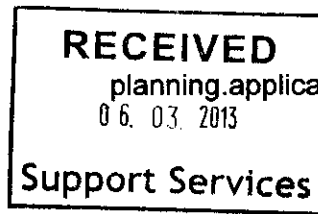
The intention is to line the walls and ceiling with Soundblock plasterboard and fibreglass acoustic quilt. This is generally as described in the British Gypsum Ltd "White Book" manual, although I cannot give a decibel reduction figure as this situation of lining a timber plank cabin has not been specifically tested. The sealing of all joints in the walls and ceiling will help the sound insulation.

The other conditions nos 1 to 4 (time limit to start, opening hours, use for dog grooming only, and materials as previously specified) are all suitable to Ms. Clifford and we do not wish to alter these.
