Hello Claire,

Firstly, any issues over the suitability of accesses into developments should be discussed with the County Council Highways people, Essex Police are not consultees in this respect. The following information should be of assistance to you however.

The following link is worth keeping, <u>TraffWeb</u> this is very easy to use, and hovering over any icon will give a little more detail. It is currently showing 5 years to end of May 2013.

This is available to all, and is on the County Council's website. It will hopefully open over the area you are asking about, though you can look anywhere in Essex for comparison. It gives 5 years of **injury** collision data, which is the only reliable data, as non-injury crashes are only recorded under certain circumstances, most usually where there has been damage to property or street furniture.

For your information, I have also pasted in below my recent response to a resident in that area concerning the same issue.

*Further to our conversation, this is the link to 'Traffweb'. This enables you to look anywhere in Essex for a 5 year period, currently showing 1/6/08 – 31/5/13.* <u>*TraffWeb</u></u>* 

I have taken a look on the other database I told you about, just for any non-injury crashes that may have been recorded. I have searched from 1/6/08 to today. Because of the nature of some these reports, it's not always easy to be precise, but I have included what little detail there maybe.

- 8 May 2010, 1314hrs, outside of **<u>186</u>**, 2 cars and brick wall damaged.
- 6 December 2010, 0730hrs, outside of **<u>184</u>**, 1 car and telegraph pole.
- 16 October 2011, 0829hrs, 3 cars, 100 yards from Hill Lane. No description unfortunately which side of Hill Lane.
- 13 November 2012, 1435hrs, 2 cars. As previous, 100 yards from Hill Lane. No description unfortunately which side of Hill Lane.
- 15 March 2013, 1937hrs, 2 cars, described as 200 metres east of Hill Lane.
- 2 June 2013, 0650hrs, outside of <u>179</u>, 1 car into a fence and telegraph pole.
