Re: Clarification of Road Classification Kinvet Close Rayleigh

We refer you to our email dated 10th October and your subsequent reply dated 15th October 2013 regarding the above.

As explained we are looking at the possible development of land in the rear garden of 193 Eastwood Road which has a boundary on Knivet Close in Rayleigh between properties nos 36 & 45. The intention is to look at the possibility of building a pair of detached properties in this location.

We understand that the normal restriction on development off of a private drive is for a maximum of 5 dwellings. However, in a recent consultation with Mr Nick Barnes at Rochford Council regarding this site he has advised that Higways officers would accept 6 here. (see attached email) To be certain of the facts we need to ascertain the demarcation line and extent of the private drive and the adopted road according to your records.
