

## Hi Peter

I have finalised the draft HRA as far as possible in line with your deadline of 30 November (tomorrow) but having contacted Charlie Williams (Natural England) regarding his concerns, he needs clarification on these (see below) and so do I for the HRA.

I've only managed to speak to him today - he was unaware of this deadline I had to get the HRA back to you tomorrow – and ask that you seek confirmation from the RSPB on these matters as a matter of urgency.

I agreed with him that it is essential to avoid needing a repeat consultation with NE if the HRA does not include the answers to these concerns so can you wait for the HRA til next week please ? We need to be confident that the HRA covers the necessary detail and NE can provide full comments on the proposal and we'd both rather it was "water tight" !

## There is currently uncertainty on 2 matters;

1) The ferry route: It is not clear from the documents what the ferry's proposed route would be.

Is there an intention to do a triangular route ? ie stopping at the Essex Marina (as the ferry from Burnham does now) and then going directly to the RSPB's new Grassland Point jetty before going back across the river to Burnham. That triangular route would involve travelling along the south side of the river for over 2km, in front of the western part of Allfleets Marsh and the saltmarsh west of Grassland Point. If the ferry did that during the winter and didn't keep far enough out from the S shoreline then it might cause significantly more bird disturbance, particularly when the high tide roost, west of Grassland Point was in use.

I recommend that the ferry route is only Burnham to Grassland Point and hope that RSPB can confirm that this is their intention. If not this mitigation measure will be necessary to avoid additional assessment and delay with the HRA.

2) Public access to the old seawall running out to the new Grassland Point jetty:

The sea wall will obviously be needed to allow people onto and off the ferry when it's running. However is the proposal to also allow people access to that seawall at other times ? If that was allowed during the winter and migration periods, then disturbance along that seawall would probably be much more frequent than the ferry's operation.

# I recommend that (except during the summer) the public should only be allowed onto the seawall running out to Grassland Point to get access to/from the ferry. If not this mitigation measure will be necessary to avoid additional assessment and delay with the HRA.





Dear Peter,

Thank you for your email with the Addendum to the Environmental Appraisal for the RSPB's passenger ferry and jetty proposal. And thank you for letting me know that, as the competent authority determining

the planning application, Rochford Council will be instructing Place Services to undertake a Habitats Regulations Assessment of the proposal and will consult Natural England on that. That should ensure we have a clear audit trail. My main comment at this stage is that, having read the Environmental Appraisal and the Addendum, I think they do provide sufficient information to carry out the HRA, including a detailed 'appropriate assessment' of disturbance effects on the SPA/Ramsar site bird features. So I think Place Services task will mainly be to organise the assessment in the stepwise HRA format; ensure all the relevant SPA, SAC and Ramsar site features are considered; use more explicit HRA terminology in places; pull out key points from the Environmental Appraisal and addendum; and come to a clear view on the mitigation measures needed to ensure no adverse effect on the integrity of the sites.

There were a couple of points where I think clarification on the proposed operation of the jetty and ferry would be useful before the HRA is completed. Feel free to get back to me if you want an explanation of those, or else let Place Services know that they can contact me about those points, or if they have any other questions related to the HRA.

I should explain that I haven't taken over Steve Roe's Land Use Planning role. But as I'm the NE responsible officer for the Crouch and Roach Estuaries SSSI, Steve discussed the proposal with me before he responded to the previous consultation. I will be involved in the same way in any future planning consultation response on the proposal, though it will probably be drafted by Steve or another Land Use Planning adviser, depending on whether or not he is back at work by then. Given that uncertainty, you could email the consultation with the HRA to me and I will share it with whoever is acting as our planning lead for Rochford at that time.

I am copying in my Marine colleague Amanda Yeomans, because she is dealing with consultations on this proposal from the Marine Management Organisation, as it also requires a Marine Licence.


