
I am happy with the construction MS – no plant is to be used and support is to be above ground as stated, there will be little if any impact to the protected woodland adjacent.







I have just had a call from Matthew who is the applicant and architect for the above address. We had conditioned the application to provide a method statement relating to the proposed outbuilding to ensure no damage would occur to Maryland Woodlands to the rear. Matthew has just clarified that the garden level is 600mm higher than the land in which the woodland is sited, meaning the excavations wouldn't reach the ground level of the woodlands.
