

They have increased the soft surface are around the Pine cat A tree, although this is just below the 20% it now improves the situation.



I remember you original comments on the new tree report and block plan, I am just not sure what to do with it. Is the wording for the standards needed as a condition or do they nee to revise their plans. Again, I am sorry I have not understood your email which is below.

"Hi Michael

I note that with the existing and new driveway most of the frontage will be hard surfaced. BS 5837 recommends the following – section 7.4.2.3 New permanent hard surfacing should not exceed 20% of any existing unsurfaced ground within the RPA. The new permanent hard surfacing across the soft surfaced grass area, within the RPA of T1, appears to exceed 20%. I suspect with the new hard surfacing and existing hard surface covering the majority of the RPA of T1, this tree will fall in to decline."
