Please note the council will not be uploading this video to its website. The video clearly shows people walking along with their children and vehicle registration plates. We have no confirmation that consent has been granted for these images to be captured on film or to be made available to the wider public via our website.

Good evening Helen and thank you for your note. We originally commissioned the time lapse video in rebuttal to what we believed to be a time lapse video from the appellant. Having late this afternoon received the hard copy photographs we would still like to have our time lapse included. As background we are very cautious about the credibility of some photographic evidence submitted with the original Bloor application. In the Ardent photographs at least one was mis-identified and others showed virtually no traffic and the time and dates of their photographs were not identified. Now referring to the photographs received in the evidence pack yesterday afternoon we would comment as follows. We note that the photographs were taken at different times of the year, ie summer and autumn/winter and we suspect selectively chosen to try to evidence a point. In appendix 5 we note that the morning time lapse first picture was on 23/11/21 at 8:20 outside the Holt Farm Schools. The morning peak in Ashingdon Road starts at 7:20 due to the fact that the King Edmund school day starts at 7:55 with pupils due in school by 7:50 latest. The Holt Farm Schools Breakfast clubs start at 7:45. Due to Covid the Holt Farm Schools start time is staggered therefore giving a misleading picture. We therefore ask for confirmation that our time lapse video be accepted as rebuttal evidence.

Apologies for the slight delay in circulating it, this is because the RSG has incorrectly thought that the appellants had submitted a time-lapse video - and the RSG video was in response to this - and the Inspector wanted confirmation that the RSG did wish it to be submitted, once they had been informed that there was no video from the appellants.

**Mr Foster** - the Inspector also asked that rather than just the video, you provide some sort of rebuttal comment to go with it - so that it is clear what the RSG's position is, with regard to the appellants' images and the RSG video. He asks that this is submitted by **close of business tomorrow, 20<sup>th</sup> January**.
