



The relocation of the top floodlights is acceptable. However, it would be better from heritage viewpoint to completely remove two floodlights from the pediment above the entrance. The floodlights on the pediments disturb its architectural appearance. Instead of replacing them it would be more acceptable to add two cylindrical lights (as previously proposed) to the sides of the porch. I have attached a photo for reference.
