As an ordinary member of the public (and taxpayer) this whole matter appears to have escalated out of all control, now involving yet more council officers and even the Bristol Planning Inspectorate, resulting in even more paperwork, bureaucrats, delays and costs to the taxpayer.

I reaffirm that I still object to this planning application for all the many reasons I have already clearly stated. I, and other interested Rayleigh residents, have already spent a great deal of care, time and money (phone calls, photocopies, postage, Recorded Delivery, etc.) clearly explaining our reasons for objecting to this planning application (including clear maps/diagrams and measurements). The main reasons are based on undisputable serious safety aspects of this proposal and also because the applicant has failed to mention that both mature and well established hedges and trees (WITH TPO's ON THEM) will have to be destroyed.

Furthermore, Essex County Council Highways Dept. has also submitted a very professional, detailed and UNBIASED submission also rejecting this application for the very same reasons mentioned by me and others.

I cannot understand, therefore, why I have now been informed that this matter has been referred to the Planning Inspectorate in far away Bristol. It has been suggested to me that the reason may be that Rochford District Council did not deal with this matter and respond to the applicant within the required statuary time limit. I emphasise that I do not know if this is the correct reason, but I will be contacting Rochford DC Planning Department for a response and explanation and to demand knowing, in writing within 3 working weeks, how many of the Planning Department staff are still WFH (Working From Home) for at least part of each working week.
