Thank you for your email. I hope you are well.

Please see the attached email response I sent to you on the 23/06/25. As this is a minor application and we didnÂ't request any conditions, whilst we were happy to provide comment on the DOC application, the advice provided is more so guidance as opposed to a formal response.

I would like to highlight that our comments for 23/00843/DOC are in relation to the surface water drainage strategy only (condition 19 of 22/00286/OUT). Conditions 17 and 18 of 22/00286/OUT which relate to foul water would typically be outside our remit.

The subsequent variation application (25/00392/FUL) makes this case more complex, however. If we were formally commenting, we would ask that where discharge is to a ditch/ordinary watercourse, the surface water rate and the foul water rate should total the greenfield 1:1 rate combined. To provide some additional context to my email issued on the 24/06/25 in relation to 25/00392/FUL, our interest would sit primarily with the discharge rates to the ditch in order to not increase flood risk downstream.

We would be unable to comment on the wording of condition 17 itself, as this condition relates to the public foul sewer network and was not requested by us. On review, would this be deemed more a matter for the water/sewerage authority and the LPA to review?

I hope that you're well.

The agent for the above infers that all the issues for the above DOC have been resolved. It appears that the applicant is proposing to discharge into a nearby ditch. However, I must draw your attention to Condition 17 of the planning approval, which is both clear and unambiguous in its requirements. The condition explicitly states that: "The foul water drainage scheme at the site shall be via connection to the public foul water sewer and the foul drainage infrastructure to achieve this shall be implemented and capable of being operational prior to commencement of the development." As such, the discharge of treated effluent into a ditch or dyke—regardless of treatment standards or landowner agreements— does not comply with the provisions of this condition. Therefore, i am of the opinion that any discharge into the ditch cannot comply with the aforementioned condition.

As you are aware they have submitted a s73 app to vary/remove a condition 17 (application ref 25/00392/FUL) - so i am unsure why they continuing to try and pursue the aforementioned DOC in its current guise. As it stands the LPA cannot support it. Just wanting to confirm that you;re in agreement before i go back to the applicant. Many thanks,

Thank you for your email. I did give your office a call, but I understand you are on leave until Tuesday.

With regards to the model included within the original report, as advised previously it did not model the entirety of the drainage system including manholes S3A, S3B and S4. We therefore still require final modelling for the site to include all drainage features and manholes (the storage tank, pump etc) up to and including the outfall location to the ditch. We would want to see the invert level of the ditch at the point of discharge and the outflow rates. Results should be provided for the 1yr, 30yr and 100yr plus 45% climate change storms with the specified input parameters, including a MADD Factor of 0.

I hope this email finds you well. I wonder if you may be able to help me. I acquired the land last July that relates to the above matter that you have been kindly consulting over the last 12 months, the last communication was in relation to the below:

- As the ditch is situated outside of the sites red line boundary and the land ownership boundary, third party agreement should be provided to discharge to the ditch.
- Please can the modelling be updated to include the entirety of the drainage system, as manholes S3A, S3B and S4 appear to be omitted. When revising the modelling, please can a MADD Factor of 0 also be used.

I can only apologise for the delay as it has taken us some time to catchup on all of the drainage related items but also find the true owner of the land/Dyke opposite our land. I am pleased to say I have now found the land owner and agreed a premium for us to discharge from the BioDisc treatment plants into the dyke and the solicitors have duly worked to produce an easement so everything is approved in terms of dyke usage and covered legally. With regards to your request to adding a MADD factor of 0 I have also had Intermodel update the designs accordingly and attach herewith.

The MADD factor of 0 is in the attached modelling. The manholes S3A and S3B have been added to the model, S4 is the outfall. Regards Ruth.


