



## Bat Survey Declaration

To be completed by the applicant or agent and returned with the planning application.

All bat species are protected by the Wildlife and Countryside Act, 1981 (as amended), and the Conservation (Natural Habitats, &c.) Regulations, 1994. This legislation makes it illegal to intentionally or recklessly kill, injure or disturb bats, or destroy their roosts<sup>1</sup>. It is therefore essential to establish whether the works being proposed will affect bats or their roosts. This questionnaire will enable the Council to determine whether bats are reasonably likely to be present in your property, and whether a detailed survey is required<sup>2</sup>.
