I, BRUCE PINKERTON, of 26 Igles, Main Road, Hawkwell, Essex, SOLEMNLY AND SINCERELY DECLARE as follows;

- I, Bruce Pinkerton, am a director of Magees Nurseries Ltd at Park Drive Nurseries, Rectory Road, Hawkwell, Essex and have been a director for 15 years and involved within the business since 1982
- The business employed a company called Aluminium to Zirconium Ltd (A to Z Ltd) to carry out metalwork construction and repairs within the mushroom sheds at the nursery. In 1989 they were looking for alternative accommodation and we agreed to rent to them a vacant building known as the Old Packing Shed (marked A on the attached plan).
- A to Z Ltd took occupation of the Old Packing Shed in 1989. For the first years of their occupation Magees Nurseries didn't charge A to Z Ltd a rent in return for a priority service agreement at a discounted rate when the Nursery required metalwork repairs and also in lieu of improvement that the company made to the building. A market rent has been charged for the premises since 1st January 2002 when the nursery employed their own repair man to carry out the works.
- A to Z Ltd expanded their business and required additional space for their workshop. In 1992 they took on the rental of an additional building known as the Bottom Glasshouse (marked B on the accompanying plan). A to Z Ltd vacated the Old Packing Shed in 2001 but continued to occupy the Bottom Glasshouse until the present day.
- In January 2001 when the Old Packing Shed became vacant the building was re-let. The tenant which took occupation in January 2001 was a business called Carp-Tech who used the building as a work shop.
- 6 Carp-Tech have continually occupied the Old Packing Shed continually since January 2001 and are still in occupation at the present time.
- 7 There has never been any written agreement for either of the above occupations.
